Sl. No.	The school is directed to ensure that:
1	The total number of sections of the school from class I to X shall be restricted to 14. The optimum number of the students shall be restricted to 40 for a classrooms size of 500 sq ft and above. Further, increase of sections shall be subject to specific approval of the Board based on the request of the school as per affiliation bye law and availability of class rooms of greater than 500 sq. ft. dimension. The school is directed to run at least 01 section each of Bal-Vatika I, II & III in accordance with established norms permitted vide Board's circular no. 12/2023 dated 24-03-2023 & 25/2023 dated 11-09-2023.
2	The school does not seem to have referred to RPwD Act and guidelines of the Board for CwSN toilets. Regular cubicle has been converted into CwSN toilet, which is too small and narrow for free movement of wheelchair/walker. The school building is G+3, but only one CwSN toilet for girls is seen in the inspection video. School has temporarily made provision of CwSN toilet for boys by placing a commode chiar on one of the Indian toilets; which is not appropriate for use of CwSN students. As per board's circular no. 11/2024 dated 09.08.2024, separate CwSN toilets for girls and boys should be maintained on the ground floor of the school building. If classes are conducted on any floor other than the ground floor, separate CwSN compliant toilets for boys and girls with adequate space for the Wheelchair / Walker must mandatorily be maintained on those floor(s) as well. School shall comply with the guidelines for

1/2025, 1	CwSN as per board's circular dated 09.08.2024, within 03 months and submit compliance with videography.
3	Mathematics lab is under stocked, poorly laid out and has not been established as per Board's SOPs. School has made arrangement of normal class desk, which is not appropriate furniture for labs. The Maths lab needs to have more kits, teaching aids, students' activity material and manipulative along with proper storage facility & seating arrangement. The school shall accordingly establish the lab as per SoP issued by the Board within 3 months and submit compliance on SARAS with videography.
4	Composite science lab has not been covered in the inspection video; hence, availability of lab with required infrastructure, as per norms, can not be ascertained and verified. Though, separate Chemistry, Biology and ATL science labs have been covered in the inspection video, but, composite science lab, which is mandatory for grant of affiliation upto secondary level, is not seen. It appears that Composite science lab has not been established by the school. The school shall accordingly establish the lab as per SoP issued by the Board within 3 months and submit compliance on SARAS with videography.
5	Ramps on the ground floor and for accessing the upper floors have been overlaid on a staircase and has steep slope gradient which is unsafe and not acceptable, as it is not as per norms of PRwD Act and guidelines issued by the Board. School has made temporary provision of ramps by placing wooden planks on the existing staircase. The ramp to access upper floors has one side handrail only. School shall either take corrective measures for adjusting the elevation of the ramp in accordance with the provisions laid down in RPwD Act or install a lift. As per board's circular no. 11/2024 dated 09.08.2024, a proper ramp should be mandatorily constructed to access the ground floor of the school's building. If the school conducts classes or Practicals for CwSN on any floor other than the ground floor, it shall mandatorily make provisions for a lift or ramp to access those floors. School shall comply with the guidelines for CwSN as per board's circular dated 09.08.2024, within 03 months and submit compliance with videography.
6	The school is directed to ensure that all essential valid documents are available under the head Mandatory Public Disclosure (as per annexure – IX) on school's website at all time and the link of certificates should be remain functional and submit an undertaking in this regard on its letter head duly signed by the principal and manager of the school in the compliance within 03 months.
7	As per the recommendation of NEP, the school shall ensure the participation of its students in Structured Assessment for Analyzing Learning (SAFAL), an exam conducted by the Board every years as per the guidelines issued by the Board vide circular no:- Acad-49/2024 dated 26th June 2024.
8	The school shall ensure the implementation of the Holistic progress Card (HPC) in the school as per the guidelines issued by the Board vide notification no. CBSE/Director (AcadAssessment)/2023 dated 27.12.2023.
9	The school shall submit an undertaking with regard to uploading completely all requisite information regarding students, teachers and infrastructure details available in the school on the UDISE Portal and OASIS Portal. The registration of the students in classes IX shall be conditional on the school providing complete information on UDISE and OASIS Portal.
10	The school shall insure to conduct at least 50 hours of Continuous Professional Development (CPD) every years for all the teachers vide notification no. 16/2021 dated 24.09.2023 out of which 25 hours should be from COE Vijayawada.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII , as the case may be.

- 1. The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
- The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4. The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., http://cbseacademic.nic.in/ & http://cbse.nic.in/ for updates.
- 5. The school shall renew mandatory certificates from time to time.
- 6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
- Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
- The school shall not remove the documents and videography links in the mandatory disclosure section
  of its website.
- 9. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted with in the stipulated 3 months, the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
